**Registration Agreement**

Welcome to the West Contra Costa Youth Soccer League (WCCYSL). Players and parents/guardians must understand and abide by the philosophy, expectations, rules and policies of WCCYSL, as outlined in the "Policies and Procedures" published by WCCYSL as well as those policies cited below. A signed copy of this document must be on file for all players who agree to play. The agreement is in effect for as long as the player(s) participate in WCCYSL-sponsored activities or until superseded by an updated agreement.

**GOOD SPORTSMANSHIP**

WCCYSL expects all players, parents and spectators to demonstrate good sportsmanship through their actions and behavior at all times. Players and parents are expected to:

- Conform to the rules established by WCCYSL in the Policies and Procedures handbook at all times;
- Respect the decisions of coaches, assistant coaches, team managers and referees and follow their instructions;
- Treat the game, officials, parents, spectators, WCCYSL players and its volunteers and opponents with dignity and respect.

**VOLUNTEER HOURS**

The West Contra Costa Youth Soccer League is a volunteer organization. WCCYSL's success is dependent on the efforts of its volunteers. During the course of the season, you may be asked to volunteer in different capacities and responsibilities. Your direct participation with the league is expected.

**TEAM PLACEMENT**

WCCYSL does not accept member requests to play for specific coaches or on specific teams. Parents and players are therefore not able to choose the coach or team for league play. Every reasonable effort will be made to accommodate "buddy requests" for those in our Recreational (In-House) Program, but such requests cannot be guaranteed.

**REFUNDS**

WCCYSL will refund registration fees for the following:

1. A full refund will be granted if the league is not able to place a player on a team roster before the start of the season.
2. Partial refund may be granted when a request is received in writing by the league at least 5 weeks prior to the scheduled first match of the season. A nominal fee may be withheld to cover administrative fees incurred by the league.
3. Pro-rated refunds may be granted when a request is received in writing by the league less than 5 weeks prior to the start of the season. Such requests must be presented to the WCCYSL Board of Directors, and require a 2/3 majority approval. Fees will be withheld to cover fees incurred by the league.

**RELEASE OF LIABILITY**

I, the parent/guardian of the above-named player, a minor, acknowledge and fully understand that each participant will be engaging in activities that may involve risk of injury, including concussion, permanent disability and death, and/or, severe economic losses which might result from their own actions, inactions, negligence of others, the rules of play, or the condition of the premises or of any equipment used; and understand, that there may be other risks not foreseeable at this time. I further acknowledge that I have received the Concussion Awareness document provided by WCCYSL and agree to abide by its guidance. **Initials:** \_\_\_\_\_
